This would then trigger a change of use.

We have received an appeal from an allotment tenant that was given a Notice to Quit due to a breach of the Allotment Tenancy. The Councillor's fully considered the matter and resolved that the NTQ will remain.

This has now gone to appeal but it envisaged that it will thrown out due to the reasons above plus the fire and pollution risk from leaking batteries.
